2. Vendors shall sell only items that have been approved on the application submitted. The market management has the sole discretion to add/delete items from the list.
3. Each individual is fully responsible for knowing the laws regarding Texas Cottage Food Laws, Taxes, Permits, Licenses and Fee's, and all rules/regulations regarding the sale of their products.
4. Code of Conduct will be enforced.
5. Code of Conduct as follows:

Any disrespectful or unacceptable behavior will be addressed and one warning will be issued. If further behavior is displayed, immediate removal will be enforced and application revoked.

## Indemnity Agreement

WHEREAS, \_\_\_\_\_ (name or business name), a vendor, charitable organization or other type of entity (User) desires to participate in Rocktoberfest; and WHEREAS, such organization meets the criteria for participation in the Rocktoberfest and agrees to obey the rules of the market and understands the nature of operating within Rocktoberfest and the East Bell Taphouse and their responsibilities as a Market Vendor or Participant in the market, including assuming responsibility for safe operation and conduct of their business within the market; the User agrees to indemnify, hold harmless and defend East Bell Taphouse, its officers, agents, employees and volunteers from and against all liability for and all claims, suits, demands, and/ or actions for damages, injuries to person (including death), property damage (including loss of use) and expenses including court costs and attorney's fees and other reasonable costs occasioned by or arising out of User's presence within the market area permitted East Bell Taphouse conducted in connection with or incidental to participation and arising out of or resulting from the intentional acts or negligence of User, its officers, agents, employees, or person participating in the event sponsored by the User.

User further agrees that it shall, at all times, exercise reasonable precautions on behalf of, and be solely responsible for the safety of its officers, agents, employees, participants, visitors, and other persons as well as their property, while in or on the market and surrounding areas. It is expressly understood and agreed that the East Bell Taphouse shall not be liable or responsible for the negligence of User, its agents, servants, employees, customers, visitors, and participants. Furthermore, it is hereby agreed that it is the User's responsibility to obtain and carry general liability insurance to protect themselves against any claims from consumers and such claims will not be the responsibility of the East Bell Taphouse.

It is further agreed with respect to the above indemnity that the East Bell Taphouse and User will provide the other with prompt and timely notice of any event covered in any way directly or indirectly, contingently or otherwise affected or which might affect the User or the East Bell Taphouse.

User further agrees that this indemnity provision shall be considered as an additional remedy for the East Bell Taphouse.
